## Proposal to Improve Korea's Graduated Response System by Newly Established Copyright Protection Commission

Under the Korea's Copyright Act, the Minister of MCST may order ISPs to delete illegal files of work on its network, to warn infringers of copyright infringement, to suspend the infringer's account up to six months, and to shut down all or parts of the bulletin board up to six months, parts of which may be called the graduated response system. The Korea Copyright Commission may also recommend ISPs to delete, to warn, and to suspend the account. Korea's graduated response system was legislated in 2009, and intended to target the webstorage system and P2P file sharing. The amendment of the Act in 2016 newly establishes the Korea Copyright Protection Commission, and the Copyright Deliberation Committee in it. The Commission and the Committee will be involved in the implementation of the graduated response system on behalf of the Korea Copyright Commission.

While the graduated response system has helped to deter copyright infringement since the first implementation in 2009, there are some defects impeding its effective and efficient implementation. This paper proposes how to improve the Korea's graduated response system. It proposes to streamline the order and the recommendation, to fix the account suspension period for six months, to ask for copyright owners to be deeply involved in the implementation, and to revitalize the shutting down of bulletin boards. And it recommend that the Commission and the Committee implement and revitalize the Korea's graduated response system.
